

Sweepstakes and Contests Legal Guidelines

SWEEPSTAKES

The following statements should be in the rules. Where appropriate, blanks have been left for information specifically tailored to the sweepstakes being promoted.

- NO PURCHASE NECESSARY.
- All federal, state and local taxes are the responsibility of the winner.
- Transportation to be provided by the winner.
- The sponsors of this sweepstakes are iBroadway and The Tony Awards. Employees of the sponsors and the sponsors' advertising and promotions agencies and their families are not eligible to participate.
- The judges' decisions are final.
- iBroadway is not responsible for entries that are late, lost, incomplete, damaged, misdirected or postage due.
- To enter, join the [iBroadway Facebook Fan Page](#) and write "iBroadway Tony Contest" on our wall before midnight EST Thursday, June 10.
- All prizes will be awarded.
- Winners List: For the name of the winner(s), after July 1, 2010, visit our Facebook page.
- All entries are the property of iBroadway.
- Void where prohibited by law.
- By accepting the prize, you consent to iBroadway's use of your name and image for promotional purposes, including online announcements, without additional compensation, except where prohibited by law.
- If by reason of a printing or other error, more prizes are claimed than the number set forth in these official rules, all persons making purportedly valid claims will be included in a random drawing to award the advertised number of prizes available in the prize category in question. No more than the advertised number of prizes will be awarded.

The following statements must be included if applicable.
